Cat/Kitten Sale Agreement

This agreement dated _____ between Svetlana Alexeev of SagiMurr Persians (Seller), and _____ (Purchaser)

(Balance must be paid in full before purchaser takes possession of kitten)

Seller and Purchaser agree to the following:

- The buyer agrees that this cat/kitten is for their use only.
- It is not to be sold, leased, or given to another individual for the use of breeding.
- Under no circumstances will this kitten/cat or any of its offspring be donated, leased, or sold to any pet store, research lab or similar facility.
- The buyer is obligated to notify the seller prior to placing the cat/kitten in any other cattery or home.
The kitten/cat named in this contract being sold WITHOUT BREEDING RIGHTS and the buyer agrees

that this cat/kitten MUST BE NEUTERED / SPAYED, before being placed in any other home or cattery.

- In case of kitten from our cattery coming to the multi-cat house, all cats in the new house suppose to be vaccinated against FVRCPCL and Rabies.

Upon Arrival- veterinary check:

Purchaser has 48 hours from the arrival time to have the kitten/cat checked by the Licensed Veterinarian of their choice. Purchaser assumes all responsibility of any vet bills incurred after delivery of kitten. If any health problems are found, written documentation signed and certified by the examining licensed veterinarian describing the health problem must be provided for review by the seller's veterinarian within 7 days. Purchaser will be refunded the purchase price after returning the kitten to the seller or replaced with another kitten/cat of the same value.

Upon Arrival - home: cat/kitten should be isolated from any household cats pending veterinary examination. Cat/kitten should be isolated for a further period from 2-10 days without contact with other household cats and without sharing of letterboxes. This time is required to allow cat/kitten to recover from the stress of changing homes. This time is flexible and relay on Purchaser observation decision.

This cat/kitten is being sold a _____ QUALITY.

Seller agrees to provide Purchaser with the kitten/cat CFA registration slip after kitten/cat has been checked and found to be in good health. (Without Litter Registration Pin #)

Health Guarantee:

Seller keeps a closed Cattery and all cats have tested negative for FeLV. Due to studies at Cornell University FIP vaccinations can potentiate actual FIP, therefore seller does not vaccinate for FIP and does not guarantee the health of kittens if they are vaccinated after going to their new homes.

The seller guarantees that their cattery is FeLV & FIV negative and that this cat/kitten is presently free of disease. This is not a guarantee against contagious diseases or accidents encountered after the buyer takes possession of the cat/kitten and the seller is not responsible for veterinary bills related to such.

The buyer acknowledges by signature of this contract said cat/kitten has not been tested for Polycystic Kidney Disease (PKD) but has been advised that both parents have been DNA tested negative for PKD. If kitten has life threatening illness due to genetics up until age **ONE YEAR**, we will replace the kitten with one of equal value as soon as one is available. Our vet must confirm the diagnosis. All transportation costs and vet fees are the responsibility of the owner. Cat **MUST** be returned to us to be replaced.

GENERAL:

- This kitten/cat will be kept indoors and not allowed to roam freely outside.
- If this kitten/cat is found to be mistreated or neglected, Purchaser agrees to surrender the kitten/cat to the seller. Forfeiting any refund of purchase price.
- Purchaser agrees to maintain the cat/kitten in good health, well groomed, combed;
- To provide a clean environment for Food and water intake;

- Not to declaw; nor to cage, Nor to keep away from the company of humans;
- This cat/kitten is well litter trained; however, the seller is not responsible if the cat/kitten is unable to locate its litter box in the new home.
